Imminent Danger

Call 911

If a student displays violent behavior toward self or others **OR** has a medical emergency **OR** is actively engaged in suicidal behavior **call 911**. The call will be directed to the Springfield Police Department. Be prepared to answer questions and provide specific details. If this is a medical emergency, you may be directed to perform life saving techniques. Remain on the line unless unsafe to do so until dispatcher indicates that you may hang up.

REQUIRED REPORTING TO TITLE IX COORDINATOR

Sexual harassment and sexual violence — including dating and domestic violence and stalking — are forms of sex discrimination prohibited by Title IX and the College Affirmative Action policy. The Title IX Coordinator is obligated to investigate alleged Prohibited Conduct occurring on campus and off campus when the conduct adversely affects the College Community, poses a threat of harm, interferes with the college's and student's pursuit of its educational objectives and mission, and/or if a student or employee is charged with a serious violation of state or federal law.
